Our 73rd Annual Meeting will be held on Friday, April 17, 2015, starting at 4:30 PM, at Mitchell's Restaurant, 304 Ross Street, Downtown Pittsburgh, light hors d' oeuvres will be served from 4:30 pm until 6:00 pm. Our Annual Business Meeting and the Election of Officers will be held at 5:00 pm followed by door prizes.

We encourage our Members to attend the Annual Meeting. You are an owner of your Credit Union, and your opinion counts.



2015 Board Elections

In accordance with our by-laws, the Nominating Committee has filed the following ballot with the CC FCU Board Secretary:

- Edward J. Kress II, Incumbent (3 year term)
- Debra Barnisin-Lange, Incumbent (3 year term)

Names of other CC FCU members may be added to the ballot by using the following procedures:

- 1. Eligible members must obtain an application and a biographical data form, either in person or by mail.
- 2. The petitioning member must obtain signatures from at least 1% (43) of valid and eligible credit union members.
- 3. The member must complete the biographical data form.
- 4. The member must then return the completed application, biographical data form, and the list of signatures to Cookie Yoder, by 4:30 PM, on Friday, February 27, 2015.

The Board Chair has appointed the following individuals to serve as the 2015 Nominating Committee: Kevin McCarthy, Chair, Michael Mayer, and Cookie Yoder.

On Monday, March 2, 2015, the application/petitions will be verified. Only qualified members in good financial standing with CC FCU will be accepted and added to the ballot. The completed ballot with biographical data of all nominees will be posted in the credit union lobby.

The ballot will be presented at the Annual Meeting on Friday, April 17, 2015. Members with a deposit of at least one share (\$25), and who are at least 18 years old, and have not been convicted of any crime or caused the credit union a loss, are eligible to vote. If a vote is needed, each member is allowed only one vote, regardless of the amount of their shares. There will be no off-site ballot boxes or proxy vote. You must be present to vote. Nominations will not be taken from the floor.



Tax Time!

It's almost tax season! That means that you can have your tax refund directly deposited into your Credit Union account quickly, easily, and FREE! According to the IRS, a refund check is issued within 6 to 8 weeks of filing a paper return. If you file a paper return, and choose to directly deposit your refund, you will receive your refund in 5 to 6 weeks. If you electronically file (E-file), your refund will be issued within 3 weeks of filing. However, if you choose to E-file and choose direct deposit for your refund, the IRS says you should receive it within 14 days.

To elect direct deposit of your tax refund into your Credit Union account, simply provide your tax preparer with your account number and our ABA routing #243083224. If you choose to E-file, you can always check the status of your refund online at www.irs.gov.

To check your refund status, you will need your social security number, your filing status, and your refund amount. Also, remember to keep your 2014 year-end statement for tax reporting purposes!
